Helix Services supports sustainable alternatives for our materials and services, resulting in the following advantages:

- Reducing of any negative impact on the environment;
- Providing work that is made to last long-term, reducing the cost to clients;

- Reducing excess waste and hazardous substances that will ultimately be disposed of in our environment;

- Sustainable businesses are a minority in the current market, and it is difficult to identify which businesses source and produce their materials sustainably;
- Sustainable materials and work are not readily available and is not the current standard required globally; and
- Becoming sustainable in all practices is not immediate and takes time for all areas of the supply chain to adopt and utilise.

Helix Services manages these advantages and disadvantages by considering the total benefit that a sustainable and socially responsible business can have on the environment and community. Although there may be a higher initial cost and effort to implement sustainable practices, the long-term effects are rewarding and will ultimately be more cost effective for us and our clients.
